The following items must accompany the application form

- 1. You need to download this form and fill in the correct sections. The form will need to be uploaded to vicroads. vic.gov.au/tow-trucks-upload, along with the supporting documentation to support your exemption application. You will have to pay a fee when you submit your documents. Once the application is submitted, you will receive a confirmation email from VicRoads.
- 2. If the transferee (purchaser) is a company, a current (not more than 3 months old) Australian Securities and Investments Commission (ASIC) company extract listing all directors must be provided.
- 3. If the transferee (which includes all directors if it's a Company) is not the holder of a current Accident Towing Driver Authority, a current (not more than 6 months old) National Police Certificate must be provided. To obtain a certificate forward a completed "Consent to Check and Release National Police Record" form direct to Victoria Police. Wait for the "National Police Record Certificate" to be returned to you before submitting the application for the transfer of tow truck licence/s.
- 4. Proof of ownership of the premises from where the tow truck is proposed to be operated from.

Either of the following will be accepted:

- A copy of a rate notice in the name of the transferee; or
- · A copy of a leasing agreement between the transferee and the owner of the premises; or
- A copy of a sub-leasing agreement between the transferee and the lessee, together with written consent from the owner of the premises.

Note: Failure to complete or provide the required documents may delay the processing of your application.

Change of Depot Address

If the transfer of tow truck licence/s also includes a change of depot address, an "Application for Variation of Conditions of Tow Truck Licence/s" completed by the current licence holder/s, will be required to accompany this application.
