

Code of Practice Management of Quarry Reference Specimens

RC 500.03

Version 7.0

1 Scope

This Code of Practice outlines the management of Quarry Reference Specimens and provides the Quarry Reference Specimen Register (QRSR). The QRSR details current Quarry Reference Specimen Lists (QRSL) to be used by quarries, testing laboratories, contractors and the Department of Transport and Planning (DTP) for assessing the quality of crushed rock and aggregate.

Any references made to 'VicRoads' or 'Department of Transport' are taken to mean Department of Transport and Planning.

2 Quarry Reference Specimen

Definition: A small quantity of representative crushed rock particles from a quarry face, usually of 10 mm nominal size, prepared in accordance with RC 372.02 and AS 1141.30.2.

A quarry reference specimen is specific to a rock source and is classified as either *Sound*, *Marginal*, or *Unsound*. The reference specimen is used in the assessment of the quality of coarse aggregates in accordance with RC 372.01 and AS 1141.30.1.

3 Quarry Reference Specimen List

Definition: A document which provides details of the reference specimens to be used in the assessment of the quality of coarse aggregates in accordance with RC 372.01 and AS 1141.30.1.

The unique identifier for a particular QRSL is its list number. If the QRSL is updated, e.g., because samples are added to or removed from the Quarry Reference Specimen set, a new list number will be automatically assigned.

Information given in the QRSL includes:

- The supplier name and supplier number
- The list number
- The status of the QRSL as either *Draft*, *Current* or *Obsolete*
- The date on which the QRSL came into effect (*Effective Date*)
- The rock type and category (e.g., rock type *Basalt*, rock category *Basic Igneous*)
- The range for applicable durability test results
- DTP or external laboratory number for each sample
- Report number of associated quarry investigation report
- Sampling date
- Durability classification (*Sound*, *Marginal* or *Unsound*)
- Sampling location.

4 Quarry Reference Specimen Register

The current QRSL list numbers applicable to individual DTP accredited suppliers are maintained in the Quarry Reference Specimen Register, as the Appendix to RC 500.03.

The QRSR will only show the supplier name and number, list number and effective date for each current QRSL, and any limitations that may apply to the scope of a supplier's accreditation. Details of the reference specimens will not be shown.

The register is reviewed during the year and updated to reflect any changes.

5 Protection of Confidentiality

In accordance with DTP Code of Practice RC 500.00, parties external to DTP or its authorised agents will not be given access to any sets of reference specimens, any quarry information (e.g., assigned values, QRSL etc.) or quarry investigation reports held within DTP unless prior permission is obtained both from the supplier who owns the rock and from DTP. A record of supplier permission granting access to any quarry information or investigation reports will be maintained by DTP.

6 Visual Assessment of Coarse Aggregates

When quarry laboratories carry out “unsound stone counts”, i.e., visual assessments of aggregate quality in accordance with RC 372.01 or AS 1141.30.1, the reference set used must be the set identified by the current List Number (GR0000...) for that supplier in Appendix A of the current version of this Code of Practice on the DTP website. In case of any discrepancies, DTP quarry accreditation officers shall be contacted for clarification.
